Considering the nature of allegations that when the defacto complainant resorted to layer form layout with reference to their own property, the petitioner herein and other accused have demanded ransom and wielded weapons and threatened the defacto complainant and considering the fact that the petitioner has also got three previous cases, this is not a fit case for grant of anticipatory bail to the petitioner.

4. Accordingly, this Criminal Original Petition is dismissed.
