COMMON ORDER

[Order of the Court was made by R.SUBRAMANIAN, J.]

Mr.S.R.A.Ramachandran, learned Additional Government Pleader takes notice for the respondents 1 and 2. Mr.M.Rajarajan, learned counsel takes notice for the 3rd respondent. By consent, this Writ Petition is taken up for final disposal at the admission stage itself.

2.Similar notice issued by the Kumbakonam Corporation was made a subject matter of challenge in W.P.(MD)No.21811 of 2024. We had by our order dated 12.09.2024, while setting aside the notice impugned, directed the respondents to proceed in accordance with law particularly in terms of Section 128(1) of the Tamil Nadu Urban Local Bodies Act, 1998. In view of the same, the impugned notice is also quashed with liberty to the authorities to proceed under the Section 128(1) of Tamil Nadu Urban Local Bodies Act, after issuing proper notice. Such action shall be commenced atleast within a period of six weeks from the date of receipt of copy of the order.
