2.Pending civil revision petition, by the order dated 22.12.2023, the petitioner was directed to pay a sum of Rs.2,00,000/- (Rupees Two Lakhs only) to the respondent on or before 04.01.2024. The remaining amount of Rs.2,25,000/- (Rupees Two Lakhs and Twenty Five Thousand only) was ordered to be deposited before the Executing Court within a period of one month, thereafter and for reporting compliance, it was listed today.
