ORDER

The learned Additional Government Pleader for the first to third respondents would submit that the second respondent *vide* his proceedings dated 15.06.2016 has directed the third respondent to conduct the enquiry. Pursuant to the same, the third respondent has conducted the enquiry and submitted a report to the second respondent. It is submitted that appropriate orders will be passed by the second respondent based on the enquiry report submitted by the third respondent.
