2. When the matter was taken up for hearing, the learned Additional Government Pleader confirmed the allegation of the writ petitioner that Survey No.1443, R.Kombai Village is a water body and that there are encroachments. It is also stated that survey has already been conducted.

3. We direct the fourth respondent to issue notices to the private respondents / encroachers for removal of encroachment. Procedure set out in the Tamil Nadu Land Encroachment Act, 1905 shall be fully complied with. Final action as per law shall be taken within a period of four months from the date of receipt of a copy of this order.

4. This Writ Petition is disposed of accordingly. There shall be no order as to costs.
