Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Declaration, to declare that the Land Acquisition Proceedings initiated under the Land Acquisition Act, 1894, with respect to the lands of an extent of 2.69 Acres comprised in S. No. 18/3, Ponmeni Village, now at Madurai West Taluk, Madurai, belonging to the petitioners as lapsed in view of the Section 24 (2) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Re-settlement Act 2013 (Act 30 of 2013).
