PRAYER :-

For Bail in Crime No.378 of 2024 on the file of the respondent police.

ORDER : The Court made the following order :-

The petitioner/A2, who was arrested and remanded to judicial custody on 12.09.2024 for the offence punishable under Section 296(b),115(2),118(1), 351(3) of BNS and Section 25(1A) of Arms Act , in Crime No.378 of 2024 on the file of the respondent police, seeks bail.

2. The case of the prosecution is that on 12.09.2024 the petitioner herein along with other accused with deadly weapons attacked the defacto complainant and his friends and also abused them in filthy language and also threatened them with dire consequences. Hence, the complaint.

3. Heard both sides

4. Considering the nature of the allegations that the petitioner along with two other persons were sitting in the entrance of the hostel and created ruckus and beat the students and one of the accused also attacked the students with aruval and caused only simple injuries and also considering the fact that no previous case is pending against the petitioner and also the fact that the petitioner is custody from 12.09.2024 and also the submission made by the learned counsel for the petitioner that he had completed ITI and working in a mechanic shop at Keelavasal area in Tanjore District, this Court is inclined to grant bail to the petitioner on certain

conditions.

5. Accordingly, this Criminal Original Petition is allowed and the petitioner is ordered to be released on bail, on executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate No.II,, Thanjavur

(i) the sureties shall affix their photographs and left thumb impression in the surety bond and the Magistrate/concerned court may obtain a copy of their Aadhar card or Bank Pass Book to ensure their identity;

(ii) the petitioner shall report before the respondent police daily at 10.30 a.m., for a period of three weeks and thereafter, as and when required for interrogation;

(iii) the petitioner shall not tamper with evidence or witness;

iv) the petitioner shall not abscond during trial.

v) On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560].

vi) If the accused thereafter abscond, a fresh FIR can be registered under Section 229A IPC.

vii) The petitioner shall file an affidavit before the trial Court informing about

his place of work and the same has to be verified by the investigation officer and ensure that the petitioner goes for proper work.
