Considering the nature of allegations that the petitioner being a married man had physical intercourse with the victim child and that the fetus was thereafter aborted and even the DNA sample was taken and RFSL report is awaited and the investigation is over and the charge sheet has also been filed, this is not a fit case for enlarging the petitioner on bail.

4. Accordingly, this Criminal Original Petition is dismissed for the present.
