ORDER

[Order of the Court was made by R.SUBRAMANIAN, J.]

The petitioner seeks leave to file an appeal against the order in W.P.(MD)No. 2486 of 2011. According to the petitioner, he has purchased the property from the legal heirs of the 5th respondent in the writ petition in the year 2015. 2. With the above observations, this writ petition is dismissed. The Writ Appeal in W.A.(MD)No.SR71241 of 2024 stands rejected in the SR stage itself. There shall be no order as to costs.
