ORDER

The present civil revision petition is filed for speedy disposal of the pending suit before the Subordinate Judge, Kulithalai, in O.S.No.93 of 2020.

2. The suit was filed in the year 2020. It is seen from the diary that there are two interlocutory applications are pending. The Learned Counsel appearing for the petitioner submitted that one of the defendants died and his legal heirs ought to be impleaded. Since the suit is not ready for trial, speedy disposal may not be an appropriate direction, especially, short time cannot be granted.
