2.The case of the prosecution is that the petitioner and the other accused are said to have received a sum of Rs.1,22,67,000/- from the victims by giving a false promise that they would secure jobs at Newzealand. Further, they also created a fake visa, flight ticket and appointment order. Hence, the complaint.

3.Heard both sides.

4.Considering the nature of the allegations in this case are a job racketing and that through the petitioner's account only the amount was transferred to the main accused and that there are 15 victims, this is not a fit case for enlarging the petitioner on anticipatory bail.

5.Accordingly, this Criminal Original Petition stands dismissed.
