2. According to the revision petitioner, the petitioner is working as a Clerk in SKT in the Indian Army and is now working in Kausani, Uttarakhand State. The petitioner filed O.P. in the year 2022 for relief of restitution of conjugal rights. It is submitted that the respondent filed a counter affidavit and proof affidavit before the Sub Court in O.P.No.143 of 2022. Thereafter, she filed H.M.O.P.No.43 of 2024 before the Sub Court after a lapse of two years. But the suit is pending without any progress. Hence, the present Civil Revision Petition is filed.
