2.Only considering the fact that even though the petitioner was enlarged on conditional bail on 27.03.2024, till date the petitioner has not come out of prison and it is stated that the petitioner has blood relatives, but they do not have any properties so as to obtain solvency certificate and no other person is also willing to stand as security to the petitioner and also considering the fact that the petitioner continues to be imprisoned in spite of bail order, I am inclined to modify the original condition.

3.Accordingly, the condition which was imposed on the petitioner is modified to the effect that the petitioner shall furnish two blood sureties and the same shall be accepted without solvency certificate.

4.In view of the fact that the condition is modified today, the time is extended by one week from the date of receipt of a copy of this order.

5. With the above said modification, this Miscellaneous Petition stands allowed.
