4.Considering the overall facts and circumstances and merits of the matter, already anticipatory bail application was dismissed by this court. There is no any change of circumstances to again entertain this petition.

5.At this juncture, the learned counsel for the petitioner would submit that subsequently the arrested accused have been released on bail. That would not be a change of circumstances to enlarge the petitioner on anticipatory bail.

6.Accordingly, this Criminal Original Petition is dismissed.
