2.The case of the prosecution is that the petitioner and other accused conspired together to forge the director's signature and the company's seal and sell them to A14 and A15.

3.Heard. Perused the materials available on record including the First Information Report.

4.Considering the nature of allegations that there has been a wrong forgery of the deeds in respect of the documents owned by the defacto complainant company and these petitioners are said to have assisted the other accused and by forging the documents, this is not a fit case for grant of anticipatory bail to the petitioners.

5.Accordingly, this Criminal Original Petition is dismissed.
