This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellant/s Mr.S.Balasubramanian and the counsel for the second respondent Mr.G.Prabhu Rajadurai are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

AWARD

The Tribunal has awarded a sum of Rs.8,867/-[Rupees Eight Thousand Eight Hundred and Sixty Seven only], as compensation with 9% interest from the date of filing of the petition.

After due deliberations, both the parties have agreed for a sum of Rs.65,000/- (Rupees Sixty Five Thousand only) as full quit. The second respondent/Insurance Company is directed to deposit the award amount, over and above the amount already deposited, within a period of four (4) weeks from the date of receipt of a copy of this award, failing which the appellant shall pay the award amount together with interest at the rate of 7.5% per annum.

On such deposit being made, the claimant is permitted to withdraw the same on filing appropriate application before the Tribunal.
