2.The case of the prosecution is that the petitioner and other accused were found to be in illegal possession of 23 kgs of ganja. Hence, the complaint.

3.Heard the learned counsel on either side and perused the material records of the case.

4.Since the petitioner's name has been specifically mentioned in the First Information Report, it cannot be said that this is a case only on the basis of the confession alone. In view thereof, I am not inclined to accept the contention of the learned Counsel for the petitioner and since I have already given directions in respect of the co-accused in Crl.OP(MD)No.16442 of 2024, following the same reasons, I am not inclined to enlarge the petitioner on bail.

5.Accordingly, this Criminal Original Petition stands dismissed.
