3.This application is filed under a wrong impression that this Court while granting anticipatory bail has directed the petitioner to furnish cash surety of Rs.25,000/- for the release of bail. This Court has imposed the condition to furnish the surety to execute a bond for a sum of Rs.25,000/- and it is not a cash surety.

4.In view of the above, there is no reason for modifying the order dated 18.06.2024 passed in Crl.O.P(MD)No.8846 of 2024. Hence, this petition is dismissed.
