The petitioner with a grievance that the Tahsildar / 1st respondent has not conducted survey based on his application, has approached this Court seeking a mandamus to direct the respondents to survey and measure the property of the petitioner in S.No.178 situated at Karisam Pulivayal, Sakkanthi Village, Pudupatti Group, Sivagangai District as per the application dated 03.10.2023

2.When the writ petition is taken up for hearing, the learned Additional Government Pleader appearing for the respondents has produced a copy of the application of this petitioner dated 03.10.2023 along with his endorsement and submits that survey was conducted on the petitioner's property and boundaries were identified on 19.01.2024. The petitioner also made an endorsement to that effect. However the petitioner has subsequently filed this writ petition as if survey was not conducted.

3.In reply, the learned Counsel for the petitioner submits that the signature of the petitioner was obtained, but survey was not conducted by the respondents. Therefore, the petitioner has approached this court.
