2.The learned counsel appearing for the petitioner would submit that the fourth respondent earlier preferred a complaint before the Alanganallur Police Station and after enquiry, the same was ordered to be closed, that subsequently, the fourth respondent has again preferred a compliant before the third respondent and that the third respondent has been harassing the petitioner.
