This criminal original petition has been filed seeking orders to quash FIR in Crime No.223 of 2020 dated 09.05.2020 on the file of the first respondent Police.

2.It is evident from the records that on the basis of the complaint given by the second respondent, FIR came to be registered against the petitioners in Cr.No.223 of 2020 for the offence punishable under Sections 147, 341, 294(b) & 506(2) IPC and that on the basis of the complaint given by the first petitioner, FIR came to be registered against the second respondent and others in Cr.No.224 of 2020 for the offence under Sections 147, 341, 294(b) & 506(2) IPC.

3.The learned Government Advocate(CrI.side) appearing for the first respondent would submit that after completion of investigation, charge sheet came to be filed in both cases.
