On 01.10.2022, he trespassed into her land and threatened her with dire consequences. Hence, she sent a representation to the respondents 1 to 3 on 13.10.2022. But, the same was not considered. Thereby, the petitioner filed this petition with the above said prayer.

3.The learned Government Advocate (Crl.Side) appearing for the State would submit that on the complaint given by the petitioner dated 13.10.2022, enquiry was conducted and the same was closed. Hence, nothing survives was further adjudication in this petition.

4. Recording the same, this Criminal Original Petition is closed with liberty to the petitioner to work out her remedy in the manner known to law.
