ORDER

The present Writ Petition has been filed by a retired Special Grade Conductor of the respondent Transport Corporation, who had attained superannuation on 30.06.2022, seeking payment of interest for the belated disbursement of terminal benefits.

2. According to the learned counsel appearing for the writ petitioner, though the petitioner has voluntarily retired from service on 30.06.2022, the terminal benefits were released only on 31.05.2023. Hence, the petitioner has addressed a communication to the respondent on 28.08.2024, seeking payment of interest for the belated disbursement of terminal benefits. Since there is no response, the present writ petition has been filed.
