This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellant Mr.C.Jawahar Ravindran and the counsel for the first respondent Mr.D.Ramesh Kumar are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

Both the parties are present along with their respective counsels. They arrived at a settlement. The claimants agreed to receive a sum of Rs. 4,25,000/-with interest at the rate of 7.5% per annum for which the appellant also conceded to them.

2.Considering the settlement arrived between the parties, the appellant is directed to deposit a sum of Rs.4,25,000/- along with interest at the rate of 7.5% per annum before the Tribunal, less the amount already deposited if any. On such deposit being made, the claimant/first respondent is permitted to withdraw the said amount of Rs.4,25,000/- (Rupees Four Lakhs Twenty Five Thousand only) with accrued interest and cost by filing necessary application before the Tribunal.
