PRAYER :-

2. Today, when the matter came up for hearing, the learned counsel for the intervenor opposes the application, and the learned Government Advocate (Criminal Side) submits that petition enquiry is pending against the petitioners.

3. Recording the same, the Criminal Original Petition is closed with a direction to the petitioners to appear before the respondent police on **30.10.2024** and thereafter, the respondent police shall complete the enquiry within a period of two weeks therefrom.
