When the matter is taken up for hearing today, the learned Government Advocate (Criminal Side) appearing for the respondents 1 to 3 would submit that the fourth respondent's father has given a complaint before the Inspector of Police, Keelakarai Police Station and is pending for enquiry and subsequently, the fourth respondent has given a complaint before the third respondent and is also pending for enquiry.

3. The learned counsel appearing for the petitioner would submit that they have already appeared before the third respondent twice.
