Considering the nature of the allegations against the petitioners that the first petitioner is a broker and the second petitioner is his wife and considering the fact that they had only actively canvassed the de-facto complainant and considering the further allegation that as a *modus operandi*, the accused are repeatedly involving in these kind of transactions, I am not inclined to enlarge the petitioner on anticipatory
