The grievance of the petitioner in this public interest litigation is that the shops inside the premises of the Tirunelveli Government Hospital has been illegally permitted.

2. The Dean of Tirunelveli Government Hospital has filed a counter affidavit stating that all the shops inside the hospital premises have been allotted, after calling for tender and the procedure
