Prayer in Habeas Corpus Petition(MD) No.1075/ 2024 :

Petition praying that in the circumstances stated therein and in the affidavit filed therewith, the High Court will be pleased H2-DO.To detention order of R-2 in No.29/BCDFGISSSV/2024 dt 19.07.2024 and quash the same and direct the Respondent to produce the body or person of the detenue by name Muniyasamy @Mounam Muniyasamy, S/o. Shanmugavel, aged 24 years, now detained as “Drug Offender” at Madurai Central Prison before this Hon'ble Court and set him at liberty forthwith and pass such further or others orders as this Hon'ble Court.

ORDER:-

This Revision/Appeal Petition coming on for orders on this day and upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Dr.R.Alagumani, Advocate for the Petitioner and of Thiru.T.Senthil Kumar, Additional Public Prosecutor for the respondents, this Court made the following order:

“The petitioner seeks direction for temporary release for 15 days. It is stated in the petition that the petitioner's wife is pregnant and that she is likely to deliver a child shortly.
