PRAYER: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondents to pay the difference amounts in the benefits in respect of Gratuity, Encashment of Earned Leave Salary, Commuted value of pension and monthly pension along with Dearness Allowance and with arrears from the date of retirement to the petitioner as per the 14th Wage Revision Settlement dated 24.08.2022 together with interest at 6% per annum for the differential payment to be computed from the date of his retirement i.e., 31.05.2022 till the date of payment within a time frame as may be fixed by this Court.
