2. The learned Government Advocate (Crl.Side) appearing for the State would submit that not even a single day, the petitioner is complying the condition imposed by this Court. Further, the petitioner cheated the defacto complainant to the tune of Rs.20,00,000/- and due to non appearance of the petitioner only, the Investigation Officer is not able to complete the investigation.
