2. One Sri.Velankanni was appointed as a B.T. Assistant (Tamil) teacher in the petitioner's school on 12.04.2016 and for approval of the said appointment a proposal was forwarded by the management on 04.06.2018 to the 4<sup>th</sup> respondent.
