The present Writ Petition has been filed by a retired Special Grade Conductor of the respondent Transport Corporation, who attained superannuation on 31.05.2022 seeking a Mandamus to disburse the monetary benefits, based upon the 12(3) settlement that was reached on 24.08.2022 with effect from 01.09.2019.

2. The petitioner has sent a representation to the respondent on 19.08.2024 seeking the above said benefits. Since there is no response, the present writ petition has been filed.

3. Heard the learned counsel appearing for the petitioner and the learned Standing Counsel appearing for the respondent.

4. Considering the above said facts, the respondent herein is directed to confer the eligible benefits upon the writ petitioner along with interest at the
