Learned Standing Counsel appearing for the respondent Bank on instructions would submit that if the petitioner submits a fresh application seeking for educational loan as prayed for in this Writ Petition, the same will be considered by the respondent Bank on merits and in accordance with law within a time frame to be fixed by this Court.

4. Learned counsel appearing for the petitioner on instructions would submit that the petitioner is willing to submit a fresh application.

5. No prejudice would be caused to any other parties, if the petitioner is allowed to submit a fresh application seeking for educational loan as prayed for in this Writ Petition and a direction is issued to the respondent Bank to consider

the same on merits and in accordance with law within a time frame to be fixed

by this Court

6. For the foregoing reasons, this Court directs the petitioner to submit a fresh application with the respondent Bank seeking for an educational loan as prayed for in this Writ Petition within a period of one week from the date of receipt of a copy of this order. On receipt of the said application, the respondent Bank shall consider the same on merits and in accordance with law and pass final orders within a period of four weeks thereafter.

7. With the above direction, the Writ Petition stands disposed of. No costs.
