Considering the nature of allegations in this case that the petitioner is said to have poured the Kerosine and set fire on the deceased and even though earlier the petitioner was released on bail, second time the petitioner has not attended the case and therefore, upon issue of NBW the petitioner was arrested and the case is not yet proceeding further only because the petitioner being absent periodically and the case is of the year 2020, for the present, I am not inclined to enlarge the petitioner on bail.
