PRAYER: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondent to revise/refix the scale of pay of the petitioner w.e.f. 01.09.2019 to till his retirement, based on the wage settlement dated 24.08.2022 and consequently to pay him difference of terminal benefits, namely Gratuity and Encashment of Leave, after revising the same based on such re-fixed scale of pay payable to him on the month of his retirement, together with 18% interest per annum, within a time frame as may be fixed by this Court.

ORDER

The present Writ Petition has been filed by a retired Special Grade Conductor of the respondent Transport Corporation seeking benefits under the 14th wage settlement, dated 24.08.2022.

According to the learned counsel appearing for the petitioner, though the petitioner had attained superannuation before the wage settlement, the wage settlement is applicable to all those employees who were in service on 01.09.2019. The petitioner has sent a representation to the respondent on 19.08.2024 seeking the said benefits. Since there is no response, the present writ petition has been filed.
