PRAYER: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondent to revise/refix the scale of pay of the petitioner w.e.f. 01.09.2019 to till his retirement, based on the wage settlement dated 24.08.2022 and consequently to pay him difference/arrears of wages for the period from 01.09.2019 to 31.05.2022 and his terminal benefits, namely Gratuity and Encashment of Leave, after revising the same based on such re-fixed scale of pay payable to him on the month of his retirement, together with 18% interest per annum, within a time frame as may be fixed by this Court.

ORDER

The present Writ Petition has been filed by a retired Special Grade Driver of the respondent Transport Corporation seeking benefits under the 14th wage settlement, dated 24.08.2022.

The petitioner has sent a representation to the respondent on 19.08.2024 seeking the said benefits. Since there is no response, the present writ petition has been filed.
