2.The learned counsel for the petitioners submitted that the petitioners have been complying with the condition imposed by this Court in CrI.O.P(MD)No.9436 of 2019 on 27.06.2024, regularly and he prayed for relaxation of the said condition.

3.The learned Government Advocate (CrI.Side) submitted that insofar as the first petitioner (A1) is concerned 17 previous cases are pending against him and insofar as A2, there is one previous case against him. He further submitted the condition has been complied with for the last 104 days.

4.Taking into consideration, the facts and circumstances of the case, the condition imposed by this Court in CrI.O.P(MD)No.9436 of 2019 on 27.06.2024 as against the first petitioner is concerned, is modified. He shall report before the respondent police every Friday at 05.30 p.m, until further orders. Insofar as the petitioners 2 and 3 are concerned, the condition is relaxed and they shall appear before the respondent police as and when required.

5.Accordingly, this petition is allowed with the above modification.
