The petitioner/accused No.6, who was arrested and remanded to judicial custody on 30.09.2024 for the offence under Sections 9(1) and 9(m) read with Section 10 of the Protection of Children from Sexual Offences Act, 2012 in Crime No.47 of 2024, on the file of the respondent Police, seeks bail.

2. The case of the prosecution is that the petitioner was working as a Watchman in a School. The allegation against the petitioner is that he committed sexual assault on the girl students.
