2. The petitioner alleges that Survey No.193, Mathur Village has been encroached upon. The learned Special Government Pleader confirmed that it is a water body. It is also stated that survey was conducted and that it disclosed the existence of the encroachment. Form I notice has been issued.

3. We direct the respondents 2 & 3 to take the process to its logical conclusion. Due process of law shall be adhered to. Notice shall be issued to all the encroachers. Encroachment shall be removed within a period of four months from the date of receipt of a copy of this order.
