The petitioner, who apprehends arrest at the hands of the respondent Police for the alleged offence under Sections 341, 294(b), 506(ii) and 307 of IPC, in S.C.No.146 of 2022, seeks anticipatory bail.

2. The petitioner is arrayed as A4 in S.C.No.146 of 2022, on the file of the Sub Court, Aranthangi, Pudukkottai District, for the offences punishable under Sections 341, 294(b), 506(ii) and 307 of IPC.

3. The petitioner was absent during the trial in S.C.No.146 of 2022, on the file of the Sub Court, Aranthangi, Pudukkottai District. Therefore non bailable warrant came to be issued on 08.12.2023.
