The petitioner / Accused No.8, who was arrested and remanded to judicial custody on 17.02.2024 and was facing trial for the offence under Sections 294(b), 307, 302, 506(ii) IPC @ 147, 148, 294(b), 302 and 307 r/w 120(B) of IPC in S.C.No.89 of 2022 on the file of the learned II Additional District and Sessions Judge, Thoothukudi, seeks bail.
