ORDER

The learned counsel appearing for the revision petitioner submitted that the above said suit has been filed by the respondents 1 and 2 / plaintiffs for declaration and injunction against the revision petitioner / 5th defendant and others and the same is being adjourned for the past four years without assigning any valid reason and therefore, the said suit may be disposed of within the time stipulated by this Court.
