ORDER : The Court made the following order :-

The petitioners/accused, who apprehend arrest at the hands of the respondent police for the offences punishable under sections 324 (2), 296(b), 115, 303, 351(3) of BNS Act, 2023 in crime no.not known of 2024, on the file of the respondent police, seeks anticipatory bail.
