To set aside the fair and decreetal order dated 03-03-2021 and made in MCOP.No.425 of 2017 on the file of Motor Accident Claims Tribunal(Special District Court), Madurai(Incharge), in so far as they relate to quantum of compesation awarded by the Tribunal to the amount restricted in the claims Petition, allow the above appeal and pass such further or other orders as this Honble Court may deem fit and proper in the circumstances of the case and thus render justice.
