ORDER : The Court made the following order :-

The petitioner/A1, who was arrested and remanded to judicial custody on 14.10.2024 for the offences under Sections 294(b), 406, 420, 379(NH), 506(ii) IPC in Crime No.167 of 2024 on the file of the respondent police, seeks bail.

2. The case of the prosecution is that the defacto complainant is running a poultry farm. The accused persons, who are the father and son, purchased chicken from the poultry farm and they were due and payable a total sum of Rs.13,47,750/-. When the defacto complainant demanded for the money, he was threatened by the accused persons. There are totally two accused persons in this case and the petitioner has been arrayed as A1.

3. Heard the learned Counsel appearing for the petitioner and the learned Additional Public Prosecutor appearing for the respondent police.

4. Taking into consideration the facts and circumstances of the case and the nature of transaction that has taken place between the parties and considering the fact that the petitioner has suffered incarceration from 14.10.2024 onwards, this

Court is inclined to grant bail to the petitioner subject to the following conditions.

5. Accordingly, the criminal original petition is ordered and the petitioner is ordered to be released on bail on executing a bond for a sum of **Rs.10,000/- (Rupees ten thousand only)** with two sureties, each for a like sum to the satisfaction of the learned **Judicial Magistrate, Valliyoor**, and on further conditions that:-

[a] the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity.

[b] the petitioner shall report before the respondent police as and when required for interrogation.

[c] the petitioner shall appear before the trial Court during every hearing date without fail.

[d] the petitioner shall not tamper with evidence or witness either during investigation or trial.

[e] the petitioner shall not abscond either during investigation or trial.

[f] On breach of any of the aforesaid conditions, the learned Magistrate/Trial

Court is entitled to take appropriate action against the petitioner in accordance with

law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]**.

[g] If the accused thereafter absconds, a fresh FIR can be registered under Section 229A IPC.
