Writ Petition filed under Article 226 of the Constitution of India, praying this court to issue a Writ of Mandamus, directing the 1st respondent to receive the surcharge amount of Rs.5,66,802/- from the petitioner by waiving the interest portion of 18 percent or by modifying the interest portion in Tha.Va.No. 16/2019 Sa. Pa, dated 10.02.2020 and consequently direct the 1st respondent to raise the attachment and drop further proceedings of sale pertaining to property in S.F.No. 298 with an extent of 1869 3/4 sq. ft in Plot No. 12 situated at Seelapadi Revenue Village, Dindigul Joint Sub-Registration, Dindigul District in E.P.No. 5/2020-21 on the file of the 1st respondent.
