ORDER

The instant writ petition has been filed by the Secretary of the third Respondent Co-operative Society seeking a mandamus to disburse the eligible subsistence allowance.

2. It could be seen from the records that the petitioner was suspended from service on 10.01.2018 and by an order dated 09.03.2018, he was imposed with a punishment of stoppage of increment with cumulative effect and later the suspension order was also revoked. However, the second respondent challenged the said order under Section 153(3) of Tamilnadu Co-operative Societies Act before the first respondent. The first respondent by his proceedings dated 04.05.2018 has passed an interim order preventing the petitioner from joining duty. It could be seen that the petitioner was implicated in a criminal case in C.C.No.1 of 2017 on the file of the Judicial Magistrate, Tirunelveli. In view of the pendency of departmental proceedings as well as the pendency of criminal case the petitioner was not permitted to
