This Criminal Miscellaneous Petition has been filed seeking an order to allow the petitioner to withdraw the amount of Rs.60,000/- (Rupees Sixty Thousand only), deposited by the respondent herein/revision petitioner, on the file of the Judicial Magistrate Court, Thiruvadanai in Crl.M.P.No.1531 of 2024 in M.C.No.4 of 2018 dated 16.08.2024.

2. In pursuant to the order of this Court, dated 19.09.2024, the respondent herein/revision petitioner has deposited a sum of Rs.60,000/- (Rupees Sixty Thousand only) on 03.10.2024 to the credit of the Judicial Magistrate Court, Thiruvadanai in Crl.M.P.No.1531 of 2024 in M.C.No.4 of 2018.
