PRAYER: Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondents to settle interest at the rate of 6% per annum for the belated payment of petitioner's terminal benefits including Provident Fund, Gratuity, Terminal Leave Salary and Commuted Value of Pension from the date of his retirement i.e., from 31.05.2022 to 31.05.2023, the date on which the said benefits were settled to the petitioner.

ORDER

The instant writ petition has been filed by a retired employee of the respondent Transport Corporation, seeking a mandamus directing the respondents to pay interest at the rate of 6% per annum for the belated payment of his terminal benefits including Provident Fund, Gratuity, Terminal Leave Salary and Commuted Value of Pension.

2. According to the learned Counsel appearing for the writ petitioner, the petitioner had attained superannuation on 31.05.2022. But the terminal benefits have paid only on 31.05.2023. Hence, he sent a representation on 13.06.2024, seeking interest for the belated payment. Since, there is no response from the respondents authorities, the present writ petition has been filed.
